ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

Offer Price

- The Offer Price has been determined at HK\$0.36 per Offer Share (exclusive of brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).

Net Proceeds from the Share Offer

- Based on the Offer Price of HK\$0.36 per Offer Share, the net proceeds from the Share Offer to be received by the Company, after deduction of the underwriting commissions and estimated expenses payable by the Company in connection with the Share Offer, are estimated to be approximately HK\$49.7 million (assuming the Over-allotment Option is not exercised). The Company intends to apply such net proceeds in accordance with the purposes as set out in the section headed “Net Proceeds from the Share Offer” in this announcement.
- If the Over-allotment Option is exercised in full, the Company will receive the net proceeds for up to 45,000,000 additional Offer Shares to be sold and transferred upon the exercise of the Over-allotment Option.

Applications and Indications of Interest Received

Hong Kong Public Offering

- The Hong Kong Offer Shares initially offered under the Hong Kong Public Offering have been very significantly over-subscribed. A total of 15,530 valid applications have been received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS for a total of 5,787,470,000 Hong Kong Offer Shares, representing approximately 192.9 times of the total number of 30,000,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offering.
- As the over-subscription in the Hong Kong Public Offering is more than 100 times, the reallocation procedure as disclosed in the section headed “Structure of the Share Offer — Re-allocation Between the International Offering and the Hong Kong Public Offering” in the Prospectus has been applied and a total of 120,000,000 International Offer Shares have been reallocated from the International Offering to the Hong Kong Public Offering. The final number of Offer Shares under the Hong Kong Public Offering is 150,000,000 Offer Shares, representing 50% of the total number of the Offer Shares initially available under the Share Offer (before any exercise of the Over-allotment Option), and being allocated to 7,363 successful applicants under the Hong Kong Public Offering.

International Offering

- The Offer Shares initially offered under the International Offering have been moderately over-subscribed, representing approximately 4.2 times of the total number of 270,000,000 International Offer Shares initially offered under the International Offering. As a result of the reallocation, the number of Offer Shares available under the International Offering is 150,000,000, representing 50% of the total number of the Offer Shares initially available under the Share Offer (before any exercise of the Over-allotment Option). The final number of Offer Shares allocated to 184 places under the International Offering is 195,000,000 International Offer Shares, which represented 150,000,000 Offer Shares as adjusted after the reallocation and over-allocation of 45,000,000 Offer Shares made in the International Offering. Such over-allocation will be covered by exercising the Over-allotment Option, which will be exercisable by the Sole Global Coordinator (on behalf of the Joint Bookrunners and the Underwriters), or by purchasing the Shares in the secondary market at prices that do not exceed the Offer Price, or through deferred settlement or by a combination of these means.
- None of the Sole Sponsor, the Sole Global Coordinator, the Joint Bookrunners, the Joint Lead Managers, the Underwriters or their respective affiliates, companies and connected clients of the lead broker or of any distributors (as defined in Appendix 6 to the Listing Rules) has been placed with any International Offer Shares for its own benefit under the Share Offer. The Directors confirm that, to the best of their knowledge, information and belief and having made all reasonable enquiries, no International Offer Shares have been allocated to applicants who are Directors, existing Shareholders or beneficial owners of Shares and/or any securities of the Company's subsidiaries and core connected persons of the Company or their respective close associates within the meaning of the Listing Rules, whether in their own names or through nominees. The Directors further confirm that the International Offering has been conducted in compliance with the placing guidelines for equity securities as set out in Appendix 6 to the Listing Rules (the "**Placing Guidelines**") and no International Offer Shares placed by or through the Joint Bookrunners and the Underwriters under the Share Offer have been placed with any core connected person (as such term is defined in the Listing Rules) or connected clients of the Company or persons set out in paragraph 5 of the Placing Guidelines, whether in their own names or through nominees. The Directors confirm that no placee will, individually, be placed with more than 10% of the enlarged issued share capital of the Company immediately after the Share Offer. None of the placees under the International Offer will become a substantial shareholder (as defined in the Listing Rules) of the Company immediately after the Share Offer and the number of Shares to be held by the public will satisfy the minimum percentage prescribed by Rule 8.08 of the Listing Rules. The Directors confirm that the three largest public shareholders of the Company do not hold more than 50% of the Shares held in public hands at the time of the Listing in compliance with Rules 8.08(3) and 8.24 of the Listing Rules. The Directors also confirm that there will be at least 300 Shareholders at the time of the Listing in compliance with Rule 8.08(2) of the Listing Rules.
- Immediately following the completion of the Share Offer, not less than 25% of the total issued share capital of the Company will be held by the public which will satisfy the minimum percentage prescribed under Rule 8.08(1)(a) of the Listing Rules.

Cornerstone Investors

Pursuant to the cornerstone investment agreements with the Cornerstone Investors as described in the section headed “Cornerstone Investors” in the Prospectus, (a) the number of Offer Shares to be subscribed by WWPKG Holdings Company Limited has now been determined to be 27,770,000 Shares at the final Offer Price (representing approximately 2.3% of the Company’s total issued Shares immediately following completion of the Share Offer, assuming the Over-allotment Option is not exercised and without taking into account the options that have been or will be granted under the Share Option Scheme); and (b) the number of Offer Shares to be subscribed for by Mr. Duncan Chiu has now been determined to be 27,770,000 Shares at the final Offer Price (representing approximately 2.3% of the Company’s total issued Shares immediately following completion of the Share Offer, assuming the Over-allotment Option is not exercised and without taking into account the options that will be granted under the Share Option Scheme). To the best knowledge of the Company, each of the Cornerstone Investors and their respective ultimate beneficial owner(s) is/are independent of each other and the Company, and is not a connected person or an existing Shareholder or close associate of the Company. Immediately following the completion of the Share Offer, the Cornerstone Investors will not have any board representation in the Company, nor will any of the Cornerstone Investors become a substantial Shareholder of the Company. The shareholdings of the Cornerstone Investors will be counted towards the public float of the Shares. Further, the Cornerstone Investors will be subject to restrictions on disposals of their Offer Shares during the period of six months starting from and inclusive of the Listing Date.

Based on the Offer Price of HK\$0.36 per Offer Share, the net proceeds from the Share Offer to be received by the Company, after deduction of the underwriting commissions and estimated expenses payable by the Company in connection with the Share Offer, are estimated to be approximately HK\$49.7 million. The Company intends to apply such net proceeds for the following purposes:

- approximately 43.2%, representing approximately HK\$21.5 million, will be used for repayment of bank borrowings after Listing;
